Ongoing development of the XC course has seen majority of jumps rebuilt over the last 3 years, track quality has been improved by grading the current tracks. New water jump complex was completed in 2012. The course now starts higher and gently follows the line across the contours, working its way downward then with a short uphill run to a new finish line. Course builder for 2018 is Mick Pineo. Main arena surface was upgraded in 2010 and all Dressage and Show jumping will be conducted on all weather sand arenas. Catering & camping available all weekend. Yards can be booked.

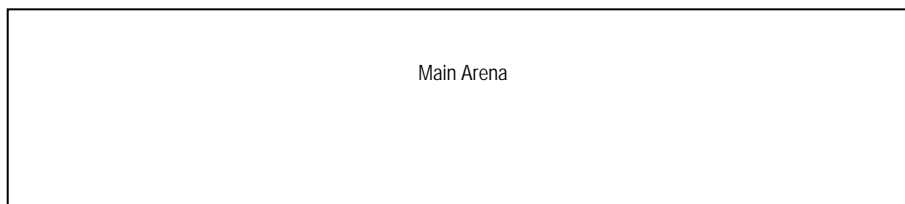
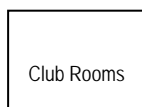

Conditions of Entry: Entry is conditional upon acceptance of these conditions.

- 1) Online entries only via www.eventsecretary.com.au/equestrian
- 2) This event is open to current EA/EV & PCAV riders, with HRCav riders ONLY allowed to compete in EvA65 class, refer item #12.
- 3) Entering this competition constitutes acknowledgement that your related PCAV or EA rules apply and acceptance of these rules.
- 4) The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
- 5) Competitors may ride up to a max of 3 horses, subject to ballot of entries. Preferences will be based on order of entry.
- 6) Max number of entries per rider per class is 2.
- 7) Medical armbands must be worn.
- 8) Helmets must be worn and comply with either EA rules or PCAV Gear rules. Spot checks may occur and incorrect helmets will mean elimination.
- 9) Rider scratching's
 - a) Must be emailed to Event Secretary (kslade@eventsecretary.com.au)
 - b) All scratching's will incur \$10 admin fee.
 - c) Scratching's received after close of entry must include either a Vet or Medical certificate to receive any refund.
 - d) No refund if notice of scratching is received after commencement of the related class.
- 10) Riders eliminated in one phase must seek approval from the organising committee to ride in remaining phases.
- 11) PC classes:
 - a) Must present current PCAV membership cards to the secretary's office before riding.
 - b) Gear check is required before each phase.
 - c) Must wear provided body competitor numbers.
 - d) If any equal placing occur the PCAV Handbook for "Separating Equality of Scores" will be applied.
- 12) EvA classes:
 - a) EvA65 - Riders can be EA "participant member", horses do NOT need to be registered.
 - b) EvA65 - PCAV & HRCav riders may enter this class but cannot compete higher than their assessed level & must present their membership and assessment cards (HRCav riders) to the secretary's office before riding.
 - c) EvA80 - Rider must be EA "Participant member" (or higher), horses do NOT require EA horse registration or "Eventing" Performance cards.
 - d) EvA95 & EvA105 - Rider must be EA "Competitor member", and horses MUST have EV horse registration and "Eventing" Performance cards.
 - e) Must report to secretary's office before commencing competition.
 - f) EV Office will verify that all entered EV riders and horses (if required) have current EA/EV membership cards prior to event.
 - g) Horse Substitutions: Yes

- i) Shall provide their own bridle and saddlecloth numbers as well as XC back number holders, however XC back number sheets will be provided and must be worn.
- 13) **Dogs & pets are prohibited without exception.**
- 14) Riders under eight years of age may not compete, horses must be at least age four, **no stallions**, colts or rigs.
- 15) Queries, protests, horse abuse rules as per the related PCAV or EA rules.
- 16) Temporary yards if used, must be of solid construction. The use of only electrified tape, strings, ropes or chains is not permitted.
- 17) **Media and Digital Publication Consent**, EV, PCAV or HRCav members/ families that are involved or attending our Horse Trials event may be photographed by official photographers, local media or event organising committee, these digital images may be used to promote the event in newsletters, flyers, websites and other promotional activities for the Pakenham Pony Club and PCAV.
- 18) Neither the organising committee of this competition nor the PCAV and/or EV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property whatsoever.
- 19) Riding times will be advised via e-mail & on www.eventsecretary.com.au
- 20) XC course will be open for walking on Sat. 10th February from 2pm.
- 21) There will be NO LUNGEING on the grounds.
- 22) Refund Policy - I understand that the Pakenham Pony Club will refund entry fees less incurred expenses if the event is cancelled.
- 23) Biosecurity conditions of Entry
- 24) **Health of Horse(s)** - I declare that the horse listed on this entry will be in good health, eating normally and not showing signs of respiratory disease during the last 3 days leading up to this event. I give my authorisation for the Event Secretary to call for veterinary inspection of the horse(s) named above and in my care should they be showing signs of respiratory illness at any time during the course of the event. I agree to pay any veterinary fees incurred as a result of this veterinary examination.
- 25) **Horse Event Declaration Wavier** - I understand that due to diseases such as equine influenza, the Victorian Department of Primary Industries, or other State or Commonwealth government body, may restrict or prevent the movement of horses, vehicles and personnel for a period of time ("Standstill"). I acknowledge and agree that a Standstill is a risk of competing at this event and I agree to pay all costs or expenses as a result of a Standstill.
- 26) **Biosecurity Guidelines** - I have read and understand the PCAV Biosecurity Guidelines as shown www.ponyclubvic.org.au website and I will act in accordance with these guidelines.
- 27) **Refund Policy** - refer item #23 above.
